

# SAFE DATE CONSUMER HEALTH DATA PRIVACY POLICY

**Effective Date: March 3, 2026**

This Consumer Health Data Privacy Policy supplements the Safe Date [Privacy Policy](#)

and applies solely to consumer health data collected from residents of jurisdictions that provide specific rights regarding such data.

If there is a conflict between this Policy and the [Privacy Policy](#), this Policy governs with respect to consumer health data.

## 1. Scope

This Policy applies to consumer health data that identifies a consumer's physical or mental health status and that is protected under applicable state law.

Safe Date does not request or require users to provide medical records or detailed medical histories. However, certain profile information or communications may be considered consumer health data under applicable definitions.

---

## 2. Categories of Consumer Health Data We May Collect

Depending on how you use the Service, we may collect:

- Self-disclosed information relating to personal health, lifestyle, or wellness preferences
- Information inferred from profile content or voluntary disclosures
- Account information associated with health-related preferences

We collect such information only when voluntarily provided or generated through use of the Service.

## 3. How We Use Consumer Health Data

We may use consumer health data too:

- Provide and operate the Service
- Display profile information as directed by you
- Improve user experience
- Maintain safety and moderation standards
- Comply with legal obligations

We do not use consumer health data for medical diagnosis or treatment purposes.

---

## 4. Disclosure of Consumer Health Data

We may disclose consumer health data:

- To service providers assisting with hosting, analytics, security, or customer support
- To comply with legal obligations
- In connection with a business transfer

We do not sell consumer health data for monetary compensation.

---

## 5. Your Rights

Depending on your state of residence, you may have the right to:

- Confirm whether we are collecting consumer health data
- Access consumer health data

- Request deletion of consumer health data
- Withdraw consent where applicable

We may require verification of identity before processing requests.

## **6. Data Retention**

We retain consumer health data only for as long as reasonably necessary to:

- Provide Service
  - Comply with legal obligations
  - Resolve disputes
  - Enforce agreements

We implement reasonable administrative, technical, and physical safeguards to protect consumer health data. However, no method of transmission or storage is completely secure.
