

## **SAFE DATE PRIVACY POLICY**

**Effective Date: March 3, 2026**

Safe Date (“Safe Date,” “we,” “us,” or “our”) respects your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard information when you use our website, mobile application, and related services (collectively, the “Service”).

By using the Service, you agree to this Privacy Policy.

### **1. Information We Collect**

We may collect the following categories of information:

#### **A. Information You Provide**

- Name
- Email address
- Phone number
- Date of birth
- Profile information
- Photos and content you upload
- Payment information (processed through third-party providers)

#### **B. Automatically Collected Information**

- IP address
- Device type and operating system
- Browser type
- Usage activity within the Service
- Log data
- Cookies and similar tracking technologies

#### **C. Verification Information**

To promote safety, we may use identity verification or screening tools. This may involve collecting government-issued identification or related documentation. We do not guarantee the conduct or background of any user.

### **2. How We Use Information**

We use information to:

- Provide and operate the Service
  - Verify user identity
  - Process payments
  - Communicate with you
  - Improve functionality and user experience
  - Enforce our [Terms](#) and [Community Guidelines](#)
  - Detect fraud or misuse
  - Comply with legal obligations

### **3. How We Share Information**

We may share information with:

#### **Service Providers**

Third-party vendors who assist with hosting, payment processing, analytics, customer support, identity verification, and security. These providers are contractually obligated to use information only for authorized purposes.

### **Legal Compliance**

Law enforcement or regulators when required by law or to protect the rights, safety, or property of Safe Date or its users.

### **Business Transfers**

In connection with a merger, acquisition, restructuring, or sale of assets.

We do not sell personal information for monetary compensation.

## **4. Do Not Sell or Share**

Certain privacy laws define “sale” or “sharing” broadly to include some types of data transfers for advertising or analytics purposes.

Safe Date does not sell personal information for monetary compensation. However, we may share limited information with service providers and analytics partners to operate and improve the Service.
