

## **SAFE DATE TERMS OF USE**

Effective Date: March 3, 2026

Welcome to Safe Date (“Safe Date,” “we,” “us,” or “our”). These Terms of Use (“Terms”) govern your access to and use of the Safe Date website, mobile applications, and related services (collectively, the “Service”).

By creating an account or using the Service, you agree to be bound by these Terms and our [Privacy Policy](#) and [Community Guidelines](#), which are incorporated by reference.

If you do not agree, do not use the Service.

---

### **1. Eligibility**

You must:

- Be at least 18 years old
- Have the legal capacity to enter into a binding agreement
- Not be prohibited from using the Service under applicable law

By using Safe Date, you represent and warrant that you meet these requirements.

We may use identity verification and related screening measures to promote safety. However, no screening process is foolproof, and we do not guarantee the conduct of any user.

### **2. Account Registration**

To use certain features, you must create an account.

You agree to:

- Provide accurate and current information
- Maintain the security of your login credentials
- Notify us immediately of unauthorized use

You are responsible for activity that occurs under your account.

We reserve the right to suspend or terminate accounts that provide false information or violate these Terms.

### **3. Community Standards**

Your use of the Service is also governed by our [Community Guidelines](#).

You agree not to:

- Harass, threaten, or abuse other users
- Impersonate any person or entity
- Post unlawful, infringing, or harmful content
- Use the Service for commercial solicitation or spam

### **4. User Content**

You retain ownership of content you post (“User Content”).

By posting content, you grant Safe Date a non-exclusive, worldwide, royalty-free license to host, display, reproduce, and distribute that content solely for operating and improving the Service.

You represent that:

- You own or have rights to the content
- The content does not violate laws or third-party rights

We may remove content at our discretion.

## **5. Subscriptions and Payments**

Certain features may require payment.

If you purchase a subscription:

- Fees and billing intervals will be disclosed at purchase
- Subscriptions automatically renew unless canceled before renewal
- You may cancel through your account settings
- No refunds are provided except as required by law

You authorize us to charge your selected payment method for recurring fees until cancellation.

## **6. Safety Disclaimer**

Safe Date promotes respectful interactions. However:

- We do not conduct comprehensive background investigations of every user.
- We do not guarantee the identity, intentions, or behavior of any member.
- Users interact at their own discretion and risk.

Always exercise caution when meeting others.

## **7. Prohibited Conduct**

You may not use Safe Date to:

- Engage in illegal activity
- Promote violence or exploitation
- Solicit prostitution, trafficking, or unlawful services
- Distribute malware or harmful code

We may cooperate with law enforcement where required by law.

## **8. Intellectual Property**

The Service, including logos, design, text, graphics, and software, is owned by Safe Date or its licensors.

You may not copy, modify, distribute, or create derivative works without permission.

## **9. Termination**

We may suspend or terminate your access:

- For violation of these Terms
- To comply with law
- To protect the safety of users

You may delete your account at any time.

Termination does not limit our right to pursue lawful remedies.

The Service is provided “as is” and “as available.”

To the maximum extent permitted by law, Safe Date disclaims all warranties, express or implied, including:

- Fitness for a particular purpose
- Non-infringement

We do not guarantee uninterrupted or error-free operations.

### **11. Limitation of Liability**

To the fullest extent permitted by law, Safe Date shall not be liable for:

- Indirect, incidental, special, consequential, or punitive damages
- Loss of data or profits
- Personal interactions between users

Our total liability shall not exceed the amount you paid to Safe Date in the twelve (12) months preceding the claim.

You agree to indemnify and hold Safe Date harmless from claims arising out of:

  - Your infringement of third-party rights

You waive the right to participate in class actions or jury trials.

Arbitration shall be conducted under the rules of the American Arbitration Association.

These Terms are governed by the laws of the State of Colorado, without regard to conflict-of-law principles.

We may update these Terms from time to time.

If changes are material, we will provide notice through the Service.

Continued use after changes constitutes acceptance.
